

INTERGOVERNMENTAL AGREEMENT RENEWAL

THIS INTERGOVERNMENTAL AGREEMENT RENEWAL (this “Renewal”) is made and entered into by and between the Illinois Finance Authority, a body politic and corporate of the State of Illinois, (the “Authority”) and the Office of the State Fire Marshal, an executive agency of the State of Illinois, (the “OSFM”) (collectively, the Authority and the OSFM may, for convenience purposes only, be referred to as the “Parties” and each individually as a “Party”).

WHEREAS, Article VII, Section 10 of the Constitution of the State of Illinois, adopted in 1970, expressly permits units of local government to contract or otherwise associate with the State of Illinois to obtain or share services and to exercise, combine, or transfer any power or function, in any manner not otherwise prohibited by law or ordinance;

WHEREAS, the Intergovernmental Cooperation Act (5 ILCS 220/1, et seq.) authorizes public agencies, which include agencies of the State of Illinois government, to jointly enjoy and/or exercise powers, privileges, functions or authority with other public agencies, except where specifically and expressly prohibited by law;

WHEREAS, the Intergovernmental Cooperation Act authorizes public agencies to enter into intergovernmental agreements with other public agencies;

WHEREAS, the Authority has been created by the Illinois Finance Authority Act, 20 ILCS 3501/801-1, et seq. (the “Act”) and is a “public agency” for the purposes of 5 ILCS 220/2(1);

WHEREAS, the OSFM has been created by the State Fire Marshal Act, 20 ILCS 2905/0.01, et seq.; and

WHEREAS, the Parties entered into an Intergovernmental Agreement (the “IGA”) effective July 1, 2020 and ending on June 30, 2025 which, by its terms, may be renewed for successive one (1) year periods upon the mutual agreement of the Parties.

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual promises and covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

1. **IGA INCORPORATION BY REFERENCE.** All terms, provisions and agreements set forth in the IGA (except to the extent expressly modified herein) are hereby incorporated herein by reference with the same force and effect as though fully set forth herein.
2. **IGA RENEWAL.** The Parties hereby mutually agree to renew the IGA; the term of this Renewal shall commence upon the Effective Date (as hereinafter defined) and shall continue until June 30, 2026, unless earlier terminated as set forth in the IGA.

3. **RECITALS.** The abovementioned recitals, as contained in the paragraphs constituting the preambles to this Agreement, are full, true, and correct and are hereby incorporated into this Agreement as if fully restated herein.
