- Strong organizational and time management skills
- Excellent interpersonal communication abilities
- Proficiency in Microsoft Office Suite (Word, Excel, PowerPoint, Outlook, Teams)
- Comfortable working independently and collaborating with professionals across sectors
- Interest in state government processes and policy development
