**NOTICE OF ILLINOIS CLIMATE BANK'S WEBINAR ON U.S. DOE GRID
RESILIENCE NOTICE OF FUNDING OPPORTUNITY**

The Illinois Finance Authority consistent with the Authority's designation as the **Climate Bank of the State of Illinois** under Illinois law (the "**Authority/Climate Bank**"), along with representatives from our State partners, will hold presentation regarding the U.S. Department of Energy (U.S. DOE) 40101(d) Federal Formula Grant Preventing Outages and Enhancing the Resilience of the Electric Grid (Grid Program). On May 20, 2024, the Authority/Climate Bank published a Notice of Funding Opportunity (NOFO) #IFA-GRID-01 inviting project pre-applications under Illinois' Grid Program award.
