- 1 CHAIRMAN ANDERBERG: All right. This is
- 2 Chairman Anderberg. I would like to call the
- 3 Governance Plus Committee Meeting to order. Would
- 4 the Assistant Secretary please call the roll.
- 5 FLETCHER: The time is 10:32 a.m. I'll take
- 6 the roll. Mr. Horne on the line?
- 7 HORNE: Yes.
- 8 FLETCHER: Mr. Goetz present?
- 9 GOETZ: Yes, here.
- 10 FLETCHER: Mr. Goetz on the line, present.
- 11 Thank you. Ms. Smoots?
- 12 SMOOTS: Here.
- 13 FLETCHER: And Chairman Anderberg?
- 14 CHAIRMAN ANDERBERG: Here.
- 15 FLETCHER: Mr. Committee Chairman, a quorum of
- 16 the Committee Members has been constituted.
- 17 CHAIRMAN ANDERBERG: Very good. On Item 2,
- 18 Review and Adoption of Open Session and Closed
- 19 Session Minutes for Governance. The open session
- 20 minutes from December 10th, 2015, have already been
- 21 approved.
- MEISTER: Yes. And I believe that Elizabeth
- 23 has a comment on the closed session minutes.
- WEBER: Right. There is a need for

- 1 confidentiality as to all or part of the closed
- 2 session minutes from December 10th, 2015. Agenda
- 3 Item 8 is Presentation and Consideration of
- 4 Resolution Regarding the Continued Need for
- 5 Confidentiality of Closed Session Minutes pursuant
- 6 to 5 ILCS 120/2.06(d), and that will address whether
- 7 those minutes remain closed until the next periodic
- 8 reviewed required by the Open Meetings Act.
- 9 I recommend that we move Item 8 up to the
- 10 closed session so we discuss all closed matters
- 11 together.
- 12 CHAIRMAN ANDERBERG: Absolutely. We'll move
- 13 Agenda Item 8 into the closed session. Does anyone
- 14 wish to make any additions, edits or corrections to
- 15 the minutes from January 8th, 2016?
- 16 MEISTER: The open session.
- 17 FLETCHER: There was no closed session in
- 18 January.
- 19 MEISTER: Okay, good.
- 20 CHAIRMAN ANDERBERG: Hearing none, I would like
- 21 to request a motion to approve the minutes. Is
- 22 there a motion?
- GOETZ: So moved. This is Mike.
- 24 CHAIRMAN ANDERBERG: And I need a second.

1	HORNE: Second.
2	CHAIRMAN ANDERBERG: So moved. So that's
3	Mr. Horne. All those in favor?
4	(A chorus of ayes.)
5	CHAIRMAN ANDERBERG: Opposed?
6	(No response.)
7	CHAIRMAN ANDERBERG: The ayes have it. On to
8	Item No. 3, Informational Presentation of the
9	Authority's Committee Structure Membership.
10	Mr. Meister.
11	MEISTER: Yes, I would like to suggest to you,
12	Chairman Anderberg, that the subject in the
13	documents that we're about to discuss on the
14	Executive Director's recommendations regarding
15	salary and title changes for the Illinois Finance
16	Authority are appropriately subject to closed
17	session, pursuant to 5 ILCS 120/2(C)(1), 11 and 21,
18	which covers personnel and compensation, review of
19	closed session minutes and potential litigation
20	under the Illinois Open Meetings Act.
21	In order to go into closed session, we
22	will need to have a motion that I think can
23	reference my statement here. Since I've provided

24 the relevant statutory cites, we will need a second,

- 1 a roll call, and then we will ask the visitors and
- 2 the other members of the staff to leave the room,
- 3 except for myself and the Board Members.
- 4 We have another pass code for the two
- 5 Board Members on the phone to call into, and then we
- 6 will have the discussion. We will then need to vote
- 7 out of closed session, again motion, second roll,
- 8 call vote.
- 9 We will not be able to make decisions on
- 10 substantive matters within closed session. It will
- 11 be discussion only, and then we can move on to the
- 12 rest of the agenda.
- 13 CHAIRMAN ANDERBERG: Okay. So to be clear,
- 14 Mr. Horne, Mr. Goetz, we'll have to do a motion.
- 15 And they'll do motion, and then they have to dial
- 16 back in.
- 17 MEISTER: Yes.
- 18 CHAIRMAN ANDERBERG: Okay.
- 19 MEISTER: And they will need to dial back in to
- 20 the initial number, which they called in now, and
- 21 Mari has provided them with the second number they
- 22 will need to call.
- GOETZ: It's the same phone number, right?
- HORNE: No, it's a different one.

- 1 GOETZ: Okay. I'm not sure I got that one.
- 2 GOETZ: It's in the script.
- 3 HORNE: Okay.
- 4 MEISTER: Mari just sent it again, Bob.
- 5 CHAIRMAN ANDERBERG: Look to Item 5. Look to
- 6 Item 5. Mike.
- 7 GOETZ: I've got it. This is Mike.
- 8 HORNE: Yeah, I got it.
- 9 MEISTER: Okay. So in order to move into
- 10 closed session for the statutory purposes that I
- 11 described, and for the purposes of the Members of
- 12 the Committee discussing the Executive Director's
- 13 recommendation regarding salary and title changes,
- 14 we'll need a motion.
- 15 CHAIRMAN ANDERBERG: So, okay. Is there a
- 16 motion to move into closed session?
- 17 SMOOTS: So moved.
- 18 CHAIRMAN ANDERBERG: Do I have a second?
- 19 HORNE: Second.
- 20 CHAIRMAN ANDERBERG: Will the Assistant
- 21 Secretary please call the roll.
- FLETCHER: Certainly. To go into closed
- 23 session, I'll call the roll. The time is 10:37 a.m.
- 24 Mr. Horne on the phone?

3	GOETZ: Yes.
4	FLETCHER: Ms. Smoots?

14	CHAIRMAN ANDERBERG: Welcome. We're back in
15	open session of the Governance Committee. And,
16	Assistant Secretary, do we need to call a roll of
17	those who are here?
18	FLETCHER: Are they back on the line?
19	CHAIRMAN ANDERBERG: Is everyone back on?
20	GOETZ: Yeah, I am. This is Mike.
21	FUNDERBURG: Rob is on.
22	GOETZ: I am. This is Mike.
23	FLETCHER: To confirm we returned to open

- 8 Brad, the matters discussed pursuant to statute of
- 9 ILCS 120/2(e) were specific to employment
- 10 compensation and performance of specific employees,
- 11 as well as for the need -- the continued need for
- 12 confidentiality of Committee closed session minutes
- 13 on December 10th, 2015.
- 14 CHAIRMAN ANDERBERG: Okay.
- 15 MEISTER: So moving on to --
- 16 CHAIRMAN ANDERBERG: No. 7.
- 17 MEISTER: No. 7, the Executive Director asked
- 18 the Committee to adopt a resolution to provide the
- 19 entire Committee, with the Executive Director's
- 20 recommendations regarding salary and title change in
- 21 preparation for the next scheduled Authority meeting
- 22 on August 11th.
- 23 CHAIRMAN ANDERBERG: Okay. And do we need a
- 24 motion? So we need a motion to accept. Do I have a
